Clerk stated that the rent charged for the week's stay was set at £80 although the owners usually paid £100. Scarrots have asked that they be permitted to open on a Sunday. Reports of more cones/road signs being moved onto the carriageway overnight. I'm attempting to find a location for a night vision camera that may reveal who finds it so amusing.

QEII Easement – Lots of work to finalise this, now all verging on completion, but OCC's final approval is pending receipt of payment from PC (see 15/05/18).

I'll take as read the e-mail shared by Cllr Williams-Cuss in relation to the suggested community BBQ event. Given the proposals, it seems to be more a matter for the Football Club to agree to the arrangements rather than the PC at this stage.

SSE were due to come back following their cabling trench work on the High Street over Christmas. I understood that this was expected to have completed some months ago, so have chased them up and also highlighted that one section in Sheards Lane has never been finished but is simply hardcore at present.

Reports of Quad Bikes using the QEII field – after some discussion it was agreed that notices would be put in the newsletter & on-site and if anyone observers these, the matter should be taken to the police.

Temporary Traffic Restriction Orders (TTRO's) – we don't appear to be receiving these any longer, so I have contacted OCC Highways and asked that they update the e-mail address for the Clerk. This follows the signs that have recently appeared advising of a weekend/daytime closure of High Street between Church Green & Horsecroft. Having checked with Openreach, I understand that they're not digging up the road, but that it is simply too narrow to allow their vehicles to access the necessary manholes. I have also highlighted to OCC that it would be the ideal opportunity for them to resolve the drainage issue on the corner of Horsecroft, which was started before Christmas, until they decided that they would have to close the road to do the necessary works.

Additionally, I have also written to OCC Highways in relation to the damage being caused to the grassed "triangle" and exposed kerb on Upper Green/Cottage Road junctions. This is mainly due to the larger service buses, but it does seem to be getting progressively worse.

Finally, I have been working with the Clerk to finalise the annual accounts, and in so doing it seems wise to forewarn you that we may need to look to replace his computer. Whilst not a discussion for tonight, it would also seem to be a good idea to look again at the possibility of introducing Internet Banking, whilst ensuring that the appropriate controls are maintained.
