Further to the report of damaged manhole cover Huntersfield garages, it is confirmed that it is the responsibility of the relevant householders. Chairman to check deeds and D.Rolls to estimate cost of repair. Also reported that village hall fence needs attention. On inspection it appears that several posts also need replacing. Clerk reminded Council that the second part 1% of the previous year's pay rise was due as from 1st April 2017 and had been approved last year.

For information to Councillors – there had been reports of a person knocking on doors and alarming residents – on investigation it appears to have been a tradesman touting for business Chairman to talk to manager of co-op regarding parking in front of shop following a business flier from a separate business distributed around village advertising parking.

Discussion with David Ashby regarding additional proposed archaeological investigations – he is proposing to use ground penetrating radar on the QEII field, and is looking to secure Council's agreement for a test pit on Upper Green. He has also expressed a desire for a longer, community dig on the Millennium Green, the details of which I will pass onto the Chair of Trustees for their consideration.

Have contacted Vale's "Big Clean Up" team to express Council's thanks in relation to the work recently conducted around the village.

2017-2018 Budget – I've been reviewing last year's spend and have proposals for this year's budget, to be considered as a separate item later this evening.

I have also been in touch with OCC regarding the verge maintenance (grass cutting) enquiry that was raised. This is currently split into two areas "Urban Area" – anything within the 30mph signs and "Rural" covering anything beyond this to the parish boundary. OCC claim that other parishes find the rate they pay covers more than a single cut with a private contractor. Given the length of verge in question, and our previous experience regarding the budget cut for this, I have personal reservations about taking on the rural areas.

I have been contacted by a resident in Manor Crescent who has issues with children kicking a ball against the wall of their house, from the shared/communal garages area, along with a request for a "no ball games sign". I have advised that it's not public land, but that it is definitely worth approaching parents, and if this causes issues, perhaps someone here might know individuals concerned and can also assist.

I've received an email regarding parking concerns outside the school entrance on Hunters Field and have shared these with the governors.

Finally, the electricity contract – whilst it had been my intention to share the details of the rates on offer, these were changing at such a rate, that it was actually necessary to agree these and therefore an extension with the current provider was best value at the time and has been secured.
