1/05/16 Election of Chairman

Cllr.P.Lewis was nominated by Cllr.Gill seconded by Cllr.Jackson. There being no other nominations, Cllr.P.Lewis was elected Chairman for 2016/2017 and duly signed the Declaration of Acceptance of Office

Chairman invited the County Councillor to address the meeting out of agenda order as she had other meetings to attend. She outlined that the evaluation of 3 or 4 Unitary Councils, as proposed by the affected District Councils, was not supported by the County Council partly due to the cost and the (unreasonable) conditions attached. The County Council would therefore be commissioning their own evaluation to assess all options (including a single Unitary Council). The government proposals regarding school academies were not supported across all parties. Following questions to the Councillor she stated that she would take the complaints and comments to the appropriate officers: Parking in Nursery End – an item the parish Council had highlighted at planning stage only to be overruled by OCC Highways –and the delays in answering correspondence e.g lighting A417 crossing

There was a question regarding the s106 funding for Faringdon – Wantage bus service and if the current operator decline to continue if the money could be diverted to the Community Bus via an application

It had been decided that the unused mobile library vehicles would be converted into playbuses Councillor will look into the grass cutting grant which had not yet been received

I've been working with the Clerk to finalise last year's accounts ahead of the annual village meeting & I've now also circulated these to members, they are of course subject to internal audit.

I'm also continuing to support the Neighbourhood Plan wherever I can – there is a need for lots of effort over coming months to both submit the Sustainability Appraisal and develop the draft Neighbourhood Plan.

Cllr.Gill reported that there were problems with 2 tyres/wheels on the mower while there were still problems with the John Deere which were being looked into by the garage Cllr Jenkins asked that the play area not be cut at 3pm when there were children from the preschool in that area
