Oxfordshire does not support the building of the Expressway irrespective of which route is chosen.OCC will work with Highways England on the development of the vision for the English Economic Heartland and the Oxford to Cambridge Arc on the understanding that they will expedite the realisation of the east-west rail link. The development of the railway line will ensure the delivery of the growth and housing required without the environmental impact of a road cutting across the centre of rural England. Building the Expressway flies in the face of Oxfordshire's commitment to reduce the use of the car, an action which is necessary to tackle the Climate Change Emergency, which Local Government including Oxfordshire has signed up to.

The proposed routes for the new Expressway have not yet been decided and Public Consultation is still to be held on the proposals. This will now take place after the General Election

CLIMATE EMERGENCY ADVISORY COMMITTEE

The inaugural meeting of this Committee took place on 15 October 2019. The Committee has recommended that the Council should aspire to become Carbon Neutral by 2030 and the District by 2045. In the first instance the Council should aim for a 75% reduction in carbon emissions in its own operations by 2025 and for the whole district by 2030.

LOCAL PLAN

Although the Vale has adopted Part 2 of the Local Plan there is still an issue with the plan for South Oxfordshire. As mentioned in our October report the Secretary of State for Housing, Communities and Local Government has stepped in and instructed that for the time being their plan is on hold. It is doubtful that any further progress will be made on this matter until after the General Election PLANNING

I am keeping an eye on all local planning and happy to talk about various applications.

The public consultation on the Oxford to Cambridge Expressway is still to be published by Highways England

Cllrs. Lewis & Warren met to review the output from the recent safety inspections. We aimed to prioritise the various observations, in terms of severity, in order to build a manageable task list. Following this, Cllrs Lewis and Jackson have been trialling a free Task Management app - ClickUp. This allows us to manage all outstanding jobs, including assigning them to individuals, setting priority, location, due dates etc. Still very much a trial, but initial findings are positive. Hoping that we will be able to give direct access to Darren & Neil in due course

Quotes for various repairs/maintenance items identified through those reports have since been obtained and will be dealt with by separate agenda items

Application for Pre-App Planning Advice submitted to VWHDC , P19/v2602/PEM. Seperate item to deal with this

Thames Water reopened Bow Road on 24/10/19 - I have since been in contact with them to confirm that works to replace the Water Main completed successfully, they have one last item to deal with the removal of the old main (which requires a 14 day delay) and they will then complete the last bit of tarmac before arranging to sweep Bow Road and the footpath

Take as read the response to Openreach in respect of their email proposing additional works to Bow Road commencing on 4/11. I have not heard back from them since then, so should they appear on site, I would suggest that we need to intervene and ask them to demonstrate/share their assessment of the impact on the Water Voles prior to any works continuing.

I was contacted by TSB Wantage ref. the change of bank signatories – and we have agreed that they should remove ex ClIr Bambury from the signatory list.

I have contacted the OCC Officer who responded on the Strategic Site applications requesting a call to discuss the proposed highways works, but nothing has been heard. I am hoping to find a way to speak with the team conductiong the consultation as another possible route.

In what transpired to be the last of the Autumn sunshine, I attempted to sow some grass seed on the two bare corners of Church Green)as had a small quantity left over at home). However, it then turned cold, and I am not convinced it will grow. There are a nimber of damaged patches around (especially Upper and Church green) and believe it would be a good idea to get a bulk bag early next year ready for a warm spell in the spring – Item to next agenda.

Flower boxes – as reported last time, I now have some information from the supplier of the "self watering" flower boxes and will work with Amanda/Tina to see if this is a viable solution for the future. Item to next agenda
